

Declaration for persons arriving or transiting by land or water

For persons who are allowed to enter or travel through Austria according to the "Order of the Federal Minister for Social Affairs, Health, Care and Consumer Protection on Entry into Austria in connection with the containment of SARS-CoV-2 (Federal Law Gazette II No. 263/2020)" as amended

1. I have my domicile or habitual residence in Austria or one of the countries listed in Appendix A and have not been in any country other than Austria or the countries listed in Appendix A in the past 14 days.

YES → please turn the page

NO → continue with point 2

2. I am entering:

1. to maintain freight and passenger traffic or
2. to carry out a repatriation trip/flight or
3. for reasons worthy of special consideration within a family context in individual cases or
4. for imperative reasons of animal care in individual cases or
5. as part of the implementation of a transfer trip/flight or
6. in the imperative interest of the Republic

YES → please turn the page

NO → continue with point 3

3. My immediate departure is ensured (proof of a flight, train, bus ticket, a taxi confirmation or similar is required)

YES → please turn the page

NO → continue with point 4

4. I have a medical certificate (in German or English according to Annexes B and C) with me about my state of health and can show that the molecular biological test for SARS-CoV-2 is negative. The medical certificate must not be older than four days at the time of arrival.

NO → continue with point 5

5. I confirm that I will start a 14-day self-monitored home quarantine or quarantine in a suitable accommodation, for which confirmation of availability must be presented and the costs must be borne by myself, which must not be left for this period, unless the immediate departure is ensured. If a molecular biological test on SARS-CoV-2 performed during this time is negative, the 14-day quarantine can be ended.

The result of any test that has been carried out must be submitted to the health authority.
